ABOUT THE VENUE

Catering: Tea/Coffee and light snacks will be available to buy from reception in Jean Brown Arena.

Please note, no food or drink (apart from water) will be allowed to be consumed in the Jean Brown Arena where the event takes place. Please use outdoor areas for eating.

Toilets: Available in the corridor next to the sports hall.

Changing Rooms: Available in the corridor next to the sport hall. However, we strongly recommend you come dressed ready for the activity you are participating in and use the changing facilities only if necessary.

Accessibility: There are accessible parking bays and toilets.

TRANSPORT INFORMATION

Public Transport

Tubes and Trains: Closest station is Fairlop (Central line) which is right next to the venue.

Buses: 462 (use Fairlop Station stop)

Parking:

All vehicles must pay if using the car park at Redbridge Sports Centre: Up to 3 hours £1.30; up to 6 hours £2.60; up to 9 hours £8 and all day is £15 on weekdays. Failure to do so will result in a parking fine being issued that LYG or the Venue will not be held responsible for.

Payment for parking can be made through app, phone or at reception via a tablet using a debit/credit card.

Any coaches wanting to drop off it is recommended you do this in the main centre car park which is the first car park you come to, to avoid getting caught in any congestion by driving up to the overflow car park.

Drop off: Free drop off up to 20 minutes. You will be fined if you stay any longer, so please make sure to pay if you do.

Once the car park is full, please use alternative car parks suggested below:

OFF –SITE PARKING

Additional parking spaces if the above car parks are full. (Pay and display only)

- D. Fairlop Station Car Park
- E. Craven Gardens Car Park
- F. *Newbury Park Station (IG2 7RN; Not shown on Map)

*You can park at Newbury Park Station on the Central Line and take tube to Fairlop Station (2 stops) and a two minute walk to Redbridge Sports & Leisure Centre

Note: Craven Gardens has a height restriction and is not suitable for minibuses.



LYG Team Managers
