Entry Info:

- **Squad Size:** Boroughs are permitted to enter a minimum of 6 competitors and a maximum of 9 competitors.
- Substitutions: Each borough is permitted two substitutions per gender, qualifiers and finals inclusive, so long as the maximum squad size on the day is not exceeded. Any additions or late entries after the entry deadline has passed will not be accepted. All substitution details must be provided at registration on the day of the event.
- **Kit & Equipment:** A junior incrediball for U13 and a senior incrediball for U15 competitions will be provided and used for the competition. Pads and gloves are not required, use of them is optional.

Results:

- Post event results will be available to download on the competition webpage within 48 hours of the competition ending. See the <u>games rules</u> rule 23.1 for further information on disputes.
- Queries on individual results can be raised in writing up to 24 hours after results have been published.
- In the event of a competition appeal, the use of external video footage and/or photographs <u>will not</u> be accepted in any circumstances.
