The season of events traditionally starts in November with Cross Country and culminates with the Finals event in July where the winning Borough are awarded with the Jubilee Trophy.

Logical Safety Solutions, hereafter referred to as LSS, has been appointed by London Youth Games, hereafter referred to as LYG, to provide a Safety Plan and various Risk Assessments to cover their works throughout the 2023-2024 LYG Season. **This RA will cover the Qualifier Competitions and Hub Finals.**

The Qualifier Competitions and Hub Finals will take place at various venues, schools / boroughs will be responsible for getting the children to and from the venue. LYG will ensure that the venues are fit for purpose, they will all be existing leisure facilities or schools. Borough leads will be issued with key information on the venue and the competitions to ensure that they are suitably prepared.
